RUCO'S NOTICE OF DISCLOSURE

21 In the spirit of full disclosure, the RESIDENTIAL UTILITY CONSUMER OFFICE
 22 ("RUCO") hereby provides notice that RUCO's Director, Jodi Jerich, is the daughter of Ron
 23 Jerich, who is a Board member of the Anthem Community Council, who also is a party in
 24

1 this rate case. The relevant law governing conflicts of interest is Arizona Revised Statutes
2 § 38-503 (B) which provides in relevant part as follows:

3 38-503. Conflict of interest; exemptions; employment
4 prohibition

5 B. Any public officer or employee who has, or whose relative
6 has, a substantial interest in any decision of a public agency
7 shall make known such interest in the official records of such
8 public agency and shall refrain from participating in any
9 manner as an officer or employee in such decision.

10 Since the Commission and not RUCO is the decision maker in this case, Ms.
11 Jerich's relationship to Mr. Jerich does not present a conflict of interest. There is no
12 conflict and one of the purposes of this notice is to avoid even the appearance of a conflict.

13 RUCO has contacted the Anthem Community Council ("Council") through one of its
14 counsel, Lawrence V. Robertson, Jr. Mr. Robertson and the Council are aware of the
15 relationship between the Jerichs and the Council and Mr. Robertson agree that no conflict
16 of interest exists.
