11 The Arizona Corporation Commission Utilities Division ("Staff") hereby files its Motion to  
 12 Extend Time to file its Surrebuttal testimony. By Procedural Order dated July 15, 2009, Staff's  
 13 Surrebuttal was due February 22, 2010. Staff requested and was granted an extension of time until  
 14 February 24, 2010.

15 Staff regrets that it was unable to file by the date scheduled. Staff witness Gerald Becker is  
 16 also the Staff witness for the upcoming Arizona-American Water rate case, Docket No. 09-0343.  
 17 Testimony in that matter was also due on February 22, 2010, but an extension of time was granted  
 18 late on February 19, 2010. Staff is requesting an additional extension of time, until Monday, March  
 19 1, 2010, to file its Surrebuttal testimony. Staff would further request that the date for the Rejoinder
