Eschelon Telecom of Arizona, Inc., Mountain Telecommunications of Arizona, Inc. and Electric Lightwave, LLC ("Integra Entities" or "Companies") filed an Application with the Arizona Corporation Commission ("Commission") on January 29, 2010 asking for authorization to serve as a borrower, co-borrower, guarantor or otherwise provide security, including encumbering assets in Arizona, in connection with financings of up to \$950 million entered into by the Companies and/or its affiliates, including its ultimate corporate parent, Integra Telecom, Inc.

The application is available for inspection during regular business hours at the office of the Commission, located at 1200 West Washington Street, Phoenix, Arizona 85007 and at the office of Rosika DeWulf & Patten, P.L.C., 400 East Van Buren Street, Suite 800, Phoenix, Arizona 85004.

Intervention in the Commission proceedings on the application shall be permitted to any person entitled by law to intervene and having a direct substantial interest in this matter. Persons desiring to intervene must file a Motion to Intervene with the Commission which must be served upon applicant and which, at a minimum, shall contain the following information: (1) the name, address and telephone number of the proposed intervenor and of any person upon whom service of documents is to be made if different than the intervenor; (2) A short statement of the proposed intervenor's interest in the proceeding; (3) Whether the proposed intervenor desires a formal evidentiary hearing on the application and the reasons for such a hearing; (4) A statement certifying that a copy of the Motion to Intervene has been mailed to Applicant. The granting of Motions to Intervene shall be governed by A.A.C. R14-3-105, except that all Motion to Intervene must be filed on, or before, the 15th day after this notice.


