10 On March 24, 2009, TracFone Wireless, Inc. ("TracFone") filed an Application for
 11 designation as an Eligible Telecommunications Carrier ("ETC") for the limited purpose of offering
 12 Lifeline and Link Up service in Arizona ("Application"). On December 18, 2009, the Arizona Local
 13 Exchange Carriers Association ("ALECA") filed a Motion to Intervene in this matter ("Motion"). On
 14 February 8, 2010, TracFone filed a response stating that it did not object to ALECA's intervention.
 15 On February 19, 2010, a Procedural Order was issued which asked Staff to file a response to
 16 ALECA's Motion to Intervene. Staff has no objection to ALECA's Motion to Intervene in the above


