
Mohave Electric Cooperative, Inc. ("Mohave"), by and through respective Legal Counsel undersigned, hereinafter respectfully request a procedural conference be set expeditiously to allow the parties to discuss potential changes to the procedural schedule for this matter, including, without limitation adjusting the filing dates of testimony for the reasons as hereinafter set forth.

Southwest Transmission Cooperative, Inc. ("Transco") is a Transmission Cooperative providing transmission services for members of Arizona Electric Power Cooperative, Inc. ("AEPSCO"). Both Transco and AEPSCO filed rate applications in the fall of 2009 and, while the matters have not been consolidated, the Procedural Schedules have been coordinated. Mohave has this date filed a Request for Expedited Procedural Conference To Discuss Potential Changes to Procedural Schedule in Docket No. E-01773A-09-0472 involving

1 the rate application of AEPCO. This simultaneous request is made in this Docket to ensure
2 continued coordination of the procedural schedules for the two matters.
