PROCEDURAL ORDER

BY THE COMMISSION:

17 On April 30, 2009, UNS Electric, Inc. ("UNSE" or "Company") filed with the Arizona
 18 Corporation Commission ("Commission") an application for a rate increase for electric service in the
 19 above-captioned docket.

20 The evidentiary hearing was held on February 4, 5, 8, 10, and 11, 2010. At the conclusion of
 21 the hearing, filings dates were set for late-filed exhibits, final schedules, and for briefs.

22 On March 1, 2010, UNSE and the Residential Utility Consumer Office ("RUCO") filed their
 23 final schedules.

24 On March 1, 2010, the Commission's Utilities Division ("Staff") filed a Motion for an
 25 Extension of Time to File Final Schedules, Late Filed Exhibits, and Extension of Briefing Schedule
 26 ("Motion"). In its Motion, Staff requested that its deadline for filing late-filed exhibit S-18 be
 27 extended from March 1, 2010, to March 12, 2010 because Staff did not receive the necessary
 28 information from UNSE until February 26, 2010 and therefore was unable to produce late-filed
 exhibit S-18 by the March 1, 2010 deadline. Staff also requested an extension for objections and
 responses to late-filed exhibit S-18 until March 19, 2010. Additionally, Staff requested that the dates
 for filing opening and reply briefs be extended to March 26, 2010 and April 9, 2010, respectively.

On March 2, 2010, RUCO filed its response to the Motion. RUCO does not oppose Staff's

1 Motion, but requests that the extensions be applied to all intervenors.

2 On March 3, 2010, UNSE filed its response to the Motion, indicating that it takes no position
3 but expressing its concern that an order be issued in time for new rates to become effective June 1,
4 2010 when the PPFAC rate adjusts.

5 Staff's Motion should be granted as modified below.

6 IT IS THEREFORE ORDERED that Staff's **late-filed exhibit S-18 and final schedules** shall
7 be filed on or before **March 12, 2010**.

8 IT IS FURTHER ORDERED that **objections and responses** to late-filed exhibit S-18 shall
9 be filed on or before **March 17, 2010**.

10 IT IS FURTHER ORDERED that all parties' **opening briefs** shall be filed on or before
11 **March 23, 2010**.

12 IT IS FURTHER ORDERED that all parties' **reply briefs** shall be filed on or before **April 2,**
13 **2010**.

14 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend,
15 or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at
16 hearing.


