PROCEDURAL ORDER

BY THE COMMISSION:

On October 1, 1998, U S West Communications, Inc. ("US West" now known as "Qwest") submitted to the Arizona Corporation Commission ("Commission") an application for deregulation of its voice messaging service.

On October 22, 1998, MCI Telecommunications Corporation and MCImetro Access Transmission Services, Inc. (collectively "MCI") filed a Motion for Leave to Intervene.

On November 5, 1998, by Procedural Order, MCI was granted intervention.

On January 25, 2010, a Procedural Order was issued requiring Qwest and Staff to file an update on this matter along with any appropriate recommendations, no later than March 8, 2010.

On February 8, 2010, Quest filed its Status Report, stating that Quest's Voice Mail Service was deregulated by Commission Decision No. 68604 (March 23, 2006). Quest's Voice Messaging Service is no longer tariffed and is included in Section 10.12 of Quest's Exchange and Network Services Catalog. Quest recommended that this Docket should be closed.

On March 8, 2010, Staff filed a Status Report. In its Report, Staff agreed with Qwest's Status Report and also recommended that the Docket be closed.

Accordingly, since the Voice Mail Service has been deregulated by Decision No. 68604, the docket should be closed.


