By Procedural Order dated February 3, 2010, the Administrative Law Judge continued the status conference in this case from February 4, 2010 to March 11, 2010. Since the date of the procedural order, Helix Telephone Company ("Helix") and Citizens Utilities Rural Company dba Frontier Citizens Utilities Rural ("Frontier") have continued their discussions regarding a mutually acceptable resolution of this case. The parties have reached a tentative agreement which is expected to be finalized within the next 60 days and filed with the Commission in this docket and in Docket T-20526A-07-0201.¹ The filing of the settlement agreement in this docket will resolve Helix's complaint against Frontier. As a result, the parties request that the status conference scheduled for March 11, 2010, be vacated at this time.


¹ Docket T-20526A-07-0201 addresses the application of Helix for a certificate of convenience and necessity to provide local exchange service in Mohave County, Arizona.
