PROCEDURAL ORDER

BY THE COMMISSION:

On September 18, 2006, Zeus Telecommunications, LLC ("Applicant" or "Zeus") filed with the Arizona Corporation Commission ("Commission") an application for a Certificate of Convenience and Necessity ("CC&N") to provide resold long distance telecommunications services in Arizona.

On January 3, 2007, the Commission's Utilities Division Staff ("Staff") filed a Letter of Insufficiency and submitted its First Set of Data Requests to Zeus.

On June 16, 2008, by Procedural Order, Staff was directed to make a filing updating the Commission on the status of Zeus' application.

On August 12, 2008, Staff filed a memorandum recommending that this docket remain open because the Applicant informed Staff it would be filing responses to Staff's First Set of Data Requests.


On January 10, 2010, by Procedural Order, Staff was directed to make a second filing updating the Commission on the status of the above-captioned application.

On February 10, 2010, Staff filed a memorandum recommending administrative closure of this docket based on the Applicant's failure to respond to Staff's data requests, phone calls, and emails and the length of time that has elapsed since the filing of the application.

Good cause has been shown for administrative closure of this docket.


