("AT&T") applies for leave to intervene and in support of its application states as follows:


1. AT&T is a telecommunications corporation certified to provide intra- and interexchange telecommunications services throughout the state of Arizona.

AT&T has an interest in agreements entered into between Qwest Corporation and other telecommunications carriers, as section 252(i) of the Telecommunications Act of 1996 allows other carriers to obtain interconnection, services and unbundled network elements under the same terms and conditions provided in the agreements.
3. AT&T's participation in this proceeding will not unduly broaden the nature or scope of the proposed merger.
