STAFF'S MOTION FOR A REVISED
PROCEDURAL SCHEDULE

The Arizona Corporation Commission Staff ("Staff") herein requests an extension of time, until Friday April 9, 2010, to file a Response to the Request for Summary Adjudication filed by Coronado Utilities, Inc. ("Coronado" or "Company") on March 22, 2010.

Pursuant to the procedural order issued in this matter on July 24, 2010, responses to motions are due within five calendar days of the filing date of the motion. However, the Company's Request for Summary Adjudication is not a simple procedural motion as is typically filed in an Arizona Corporation Commission ("Commission") rate proceeding. Rather the Company argues that Staff's recommendations, made through direct pre-filed testimony, are "in conflict with law."¹ The Company's Request for Summary Adjudication involves non-procedural substantive legal arguments regarding the legality of Staff's recommendations and requests a final disposition of substantive legal issues. Therefore Staff respectfully requests additional time to allow an opportunity to respond to the Company's legal arguments and characterization of Staff's recommendations.
