PROCEDURAL ORDER

**BY THE COMMISSION:**

By Procedural Orders dated July 9, 2002 and August 15, 2002, the Hearing Division directed Commission Staff to file recommendations for further action concerning its investigation into Qwest Corporation's compliance with Section 252(e) of the Telecommunications Act, and directed interested parties to file written comments to the Staff's recommendations by August 29, 2002.

Staff filed its Supplemental Staff Report and Recommendations on August 14, 2002.

AT&T Communications of the Mountain States, Inc. and TCG Phoenix (collectively "AT&T"), WorldCom, Inc. ("WorldCom"), Qwest Corporation ("Qwest") and the Residential Utility Consumer Officer ("RUCO") filed comments to the Staff Report.

On September 4, 2002, Staff filed a Reply to the Comments of WorldCom, AT&T and RUCO.

On September 6, 2002, RUCO file a Motion for Procedural Conference to resolve conflicting views on the scope of the hearing.

IT IS THEREFORE ORDERED that a Procedural Conference of the purpose of clarifying the parties' positions as expressed in their written comments and to establish a time-frame for proceeding with a hearing as well as any other issues related to this matter the parties wish to bring to the attention of the Commission, shall commence on September 19, 2002, at 10:00 a.m. at the Commission's offices, 1200 W. Washington Street, Phoenix, Arizona.<sup>1</sup>
