VIII. INTRASTATE NETWORK SERVICES LOCAL ACCESS SERVICE

1. **SERVICE DESCRIPTION:** Intrastate Network Services Local Access Service is provided by the Company. Intrastate Network Services Local Access Service is a point-to-point service which provides the Customer access to Company network services through a circuit from the Customer's designated premises to the Company's Point-of-Presence (POP). The connections of the circuit may, or may not, be provided by Company facilities but the circuit itself is provided by the Company. Intrastate Network Services Local Access Service may be provided in the following arrangements: (T)

1.1.1 Product Description: Intrastate Analog Local Access is provided by the Company. Intrastate Analog Local Access is a service that provides channels with voice frequency transmission capability in the nominal frequency range of 300 to 3000 Hz and may be terminated over two-wire or four-wire.
