**MOTION FOR EXTENSION AND  
REQUEST FOR PROCEDURAL  
CONFERENCE (EXPEDITED)**

22 The Arizona Corporation Commission Utilities Division ("Staff") hereby files its Motion to  
 23 Extend Time to file the rate design testimony and request for procedural conference. By Procedural  
 24 Order dated March 1, 2010, Staff was granted an extension of time to file its direct testimony until  
 25 March 8, 2010. Because Staff's rate design testimony is dependent upon its revenue requirement,  
 26 Staff requests additional time in order to prepare its rate design and its proposal on rate design to  
 27 address consolidation. Staff would request an extension of time to file its rate design testimony until  
 28 March 29, 2010.

Staff would further request an extension of time to file its Surrebuttal testimony and that all  
 Intervenor be granted the same extension of time until April 15, 2010. Staff has discussed its  
 proposed new schedule with the parties. The Company and RUCO are in agreement.

1 As was ordered in the Procedural Order of March 1, 2010, Staff met telephonically, on March  
2 5, 2010, with the parties to discuss any proposed schedule changes. The following schedule for the  
3 remaining filings was proposed:
