PROCEDURAL ORDER

BY THE COMMISSION:

On May 23, 2001, the Federal Communications Commission ("FCC") issued its Fourteenth Report and Order and Twenty-Second Order on Reconsideration, and Further Notice of Proposed Rulemaking in CC Docket No. 96-45 and the Report and Order in CC Docket No. 00-0256 ("FCC Rural Carrier High Cost Support Order"). The FCC Rural Carrier High Cost Support Order delegates certain responsibilities to State Commissions, including review of Rural Carrier Disaggregation Plans.

On November 16, 2001, the Arizona Corporation Commission ("Commission") opened the above-captioned docket, and the Commission's Staff filed a Request for a Procedural Order.

Procedural Orders were issued on November 20, 2001, and January 16, 2002.

On January 6, 2003, Staff filed a Request for Procedural Schedule. In its request, Staff suggested the following schedule:




