Dear Taxing Authority:

This letter is to inform you that the above referenced corporation filed for Chapter 11 bankruptcy protection on June 25, 2001. The deadline for filing a proof of claim for payment expired on October 31, 2001 and final distributions to creditors are scheduled for October 31, 2002.

2nd Century ceased operations in all locations except Miami and Tampa, Florida; Atlanta, Georgia; and Houston, Texas on December 15, 2000. The corporation ceased operations in those final four locations on June 30, 2001.

2nd Century was a start-up corporation formed in 1998, which never achieved a sufficient customer base to operate profitably. As such, it had no net income in any operating period.
