17 **BY THE COMMISSION:**

18 On September 4, 2002, the Utilities Division ("Staff") of the Arizona Corporation  
19 Commission ("Commission") filed a Complaint for failure of numerous utility companies to file their  
20 2001 Utilities Division Annual Reports ("Annual Reports"). Therein, Staff requested that financial  
21 penalties be assessed and that the respective utilities' Certificates of Convenience and Necessity

1           Therein, the Commission ordered a hearing to be conducted at a date and time set by the  
2 Hearing Division.

3           On October 15, 2002, by Procedural Order, a pre-hearing conference was scheduled for  
4 November 7, 2002, and a hearing was scheduled for December 12, 2002.

5           On November 7, 2002, at the pre-hearing conference, Staff appeared with counsel. None of  
6 the Respondents appeared. The conduct of the hearing was discussed and Staff pointed out that,  
7 subsequent to the Complaint herein, the following nine Respondents had filed for the cancellation of  
8 their Certificate(s):

17           On November 7, 2002, by Procedural Order, these applications of the nine Respondents  
18 requesting cancellation were consolidated herein.

19           On November 13, 2002, by Procedural Order, Staff was directed to file a Staff Report which  
20 was to address the applications for cancellation.

21           On November 14, 2002, Buddy's Bar, Inc. also filed an application for cancellation in Docket  
22 No. T-02911A-02-0849.

23           On December 10, 2002, Staff filed its report on the majority of the applications for  
24 cancellation. Two additional Staff Reports were also filed with respect to the applications for  
25 cancellation.

26           On December 12, 2002, a full public hearing was held by the Commission at its offices in  
27 Phoenix, Arizona before a duly authorized Administrative Law Judge of the Commission. Staff  
28 appeared with counsel. No other parties named in the proceeding appeared. At the conclusion of the

1 hearing, the matter was taken under advisement pending submission of a Recommended Opinion and  
 2 Order to the Commission.

4 Having considered the entire record herein and being fully advised in the premises, the  
 5 Commission finds, concludes, and orders that:

6 **FINDINGS OF FACT**

7 1. Pursuant to authority granted by the Commission, the Non-filing Respondents were  
 8 authorized to conduct business at various times in Arizona as public utilities.

9 2. On September 4, 2002, Staff filed a Complaint against the Non-filing Respondents due  
 10 to their failure to file their 2001 Annual Reports as follows:

11 6. Commission records reveal that Potato Patch Water Service, Inc., recently had its  
12 Certificate cancelled by the Commission in Decision No. 65465 (December 19, 2002) in a transfer of  
13 assets and adjudication proceeding.

14 7. Notice of the proceeding was given in the manner prescribed by law.

15 8. A number of the Commission's Procedural Orders which contained the notice of the  
16 proceeding's pre-hearing conference and the hearing mailed to the Non-filing Respondents' last  
17 known addresses were returned to the Commission with notations such as "return to sender, no  
18 forwarding order on file", "moved, left no address, unable to forward", and "forwarding order  
19 expired".

20 9. Ms. Madrid indicated that prior to the Complaint being filed, the Commission sent out  
21 delinquent notices to all of the Non-filing Respondents to advise them that they had failed to file their  
22 2001 Annual Reports. Since there was continued non-compliance, the Complaint was prepared and  
23 filed.

24 10. Staff is recommending that the Certificates of the Non-filing Respondents which have  
25 either failed to file their 2001 Annual Reports and/or failed to advise the Commission of their proper  
26 mailing addresses be revoked and subject to financial penalties.

27 11. With respect to the Late-Filed Respondents, Staff is recommending the dismissals of  
28

1 the Complaint herein.

2 12. With respect to the applications by the Cancellation Respondents, Staff is  
3 recommending that their Certificate(s) be cancelled and the respective Dockets for cancellation be  
4 administratively closed.

5 13. With respect to one Cancellation Respondent, CEO Telecommunications, Inc.  
6 ("CEO"), an interexchange telecommunications service provider, Staff pointed that Legent  
7 Communications Corporation ("Legent")<sup>5</sup> had acquired CEO's customer base and related non-  
8 tangible assets which were not useful and necessary in the performance of its duties to the public.  
9 Although CEO and Legent did not believe Commission approval of the transaction was necessary  
10 due to A.R.S. § 40-285(C), on July 22, 2002, they filed an application which requested the  
11 Commission's approval. This application was assigned Docket Nos. T-04084A-02-0551 and T-  
12 03152A-02-0551.

13 14. Evidence was provided to Staff by CEO that it had provided written notice to its  
14 customers of Legent's acquisition of the customer base and its assumption of CEO's duties.  
15 Customers were also advised that they could choose one of the numerous alternate service providers  
16 if they did not want service from Legent. Staff also confirmed that there were no complaints against  
17 CEO concerning any refunds of customer advances, deposits and/or prepayments.

18 15. Staff is recommending that the Commission approve the transaction between CEO and  
19 Legent because sufficient notice was provided to CEO's customers and they have many alternate  
20 providers to choose from if they do not want service from Legent. Staff is also recommending the  
21 administrative closure of Docket Nos. T-04084A-02-0551 and T-03152A-02-0551.

22 16. Based upon our review of the record, we believe that Staff's recommendations are  
23 appropriate and that the Certificate(s) of the above-described Non-filing utilities and/or individuals  
24 should be revoked and that they should also be assessed financial penalties. However, if any affected  
25 Non-filing Respondent files, within 30 days of the effective date of this Decision, its 2001 Annual  
26 Report, then the Order of revocation and penalty as to that utility and/or individual should be

1 rendered null and void without further Order by the Commission. At the end of the 30 day period,  
2 Staff should file a compliance document indicating which, if any, of the Non-filing Respondents have  
3 filed their 2001 Annual Report so that the Order of revocation and penalty should be rendered null  
4 and void. The Complaint against the Late-filing Respondents should be dismissed.

5 17. We also find that as to the requests of the Cancellation Respondents, the Complaint  
6 herein should be dismissed, their requests for cancellation should be approved and no penalties  
7 should be ordered against them.

8 18. Lastly, we should approve the CEO/Legent transaction and Docket Nos. T-04084A-  
9 02-0551 and T-03152A-02-0551 should be administratively closed.

### 10 CONCLUSIONS OF LAW

11 1. The above-referenced Non-filing Respondents are public service corporations within  
12 the meaning of Article XV of the Arizona Constitution and A.R.S. §§ 40-281, 40-282 and 40-252.

13 2. The Commission has jurisdiction over the Non-filing Respondents and of the subject  
14 matter of the Complaint herein.

15 3. The revocation of the Certificates of the Non-filing Respondents who have neither  
16 late-filed their 2001 Utilities Division Annual Reports or applied for cancellation hereinabove as  
17 described in Findings of Fact Nos. 4 and 5 would benefit the public interest.

18 4. The Complaint against the Late-filing Respondents, the Cancellation Respondents and  
19 the Potato Patch Water Service, Inc. should be dismissed and no penalties assessed.

20 5. The applications for the cancellation of their Certificate(s) by the Cancellation  
21 Respondents should be approved.

22 6. The CEO/Legent transaction should be approved and Docket Nos. T-04084A-02-0551  
23 and T-03152A-02-0551 should be administratively closed.

24 7. Pursuant to A.R.S. § 40-425, the Non-filing Respondents should also each be  
25 penalized the sum of \$250 unless, within 30 days of the effective date of this Decision, the Non-filing  
26 Respondent files its 2001 Utilities Division Annual Report.
