BY THE COMMISSION:

On June 1, 1999, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing Regarding Proposed Order for Relief, naming Respondents William Boyd Gregory, Irma Delores Sanchez, Eye International, L.L.C., and American International Beneficial Association, Inc.

On July 23, 1999, Respondents filed with the Commission requests for a hearing, requesting a hearing pursuant to A.R.S. § 44-1972 and A.A.C. R14-4-306.

On July 27, 1999, by Procedural Order, the above matter was set for hearing on August 19, 1999.


On August 9, 1999, Mr. Gregory and related Respondents telephonically requested a continuance in order to retain counsel. The Division did not oppose this request.


