PROCEDURAL ORDER

BY THE COMMISSION:

On May 18, 1999, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing Regarding Proposed Order for Relief ("Notice") against Mr. James Troy Bredeson, Mr. Ronald John Hoover, Mr. Lowell Robert Taylor a/k/a Jim Taylor and Mr. Patrick Robin Hogue in which the Division alleged multiple violations of the Securities Act ("Act") in connection with the offer and sale of securities in the form of evidences of indebtedness and investment contracts.

Mr. Taylor was duly served with copies of the Notice.

On May 27, 1999, counsel for Mr. Taylor filed a timely request for hearing. No other requests for hearing were filed.

On June 21, 1999, a pre-hearing conference was held, and counsel for Mr. Taylor and the Division stipulated to a hearing being scheduled for August 26, 1999, at 9:30 a.m. at the

1 Commission's offices in Phoenix, Arizona unless a settlement was reached prior to the hearing date.

2 IT IS THEREFORE ORDERED that a hearing shall be held on August 26, 1999, at 9:30 a.m.,
3 at the Commission's offices, 1000 West Washington Street, Phoenix, Arizona.


