AEPCO requests that the Administrative Law Judge schedule a procedural conference at a convenient date and time the week of April 5¹ to discuss (1) recent settlement agreements among the members and corresponding revisions to AEPCO's rate filing and (2) a revised procedural schedule for this matter.

Staff, AEPCO, Trico, SSVEC and MEC have discussed these issues over the past few weeks. Attached as Exhibit A is a revised procedural schedule which they have agreed to. For the convenience of the Judge, the second page of the exhibit summarizes the current schedule for the AEPCO and SWTC rate cases.

AEPCO requests that the Administrative Law Judge schedule a procedural conference to discuss these issues and will provide a telephonic bridge for the convenience of the hearing division and parties.
