PROCEDURAL ORDER

BY THE COMMISSION:

On June 4, 2009, Adaman Mutual Water Company ("Adaman" or "Company"), filed with the Arizona Corporation Commission ("Commission") an application for approval to issue stock ("Application").

On June 12, 2009, the Company filed its Amended Application.

On October 7, 2009, the Company filed an Affidavit of Publication indicating that it had published notice of the Application in *The Record Reporter* on October 5, 2009.

On February 5, 2010, the Commission's Utilities Division Staff ("Staff") filed its Staff Report in this docket recommending approval of the Application subject to certain terms and conditions.

On February 19, 2010, Adaman filed its Comments to Staff Report requesting certain changes to the Staff Report.

On February 25, 2010, a Procedural Order was issued directing Staff to file its Reply to Adaman's Comments to the Staff Report ("Comments").

On March 22, 2010, the Company filed a Motion to Amend Application, in which it requested additional relief ("Motion").

On March 24, 2010, Staff filed a Request for Extension of time to file its Reply to Adaman's Comments. In the Request for Extension, Staff states the additional time is needed "in light of the substantial modification of the approvals that the Company is requesting in its amended application." Staff also notes that Staff does not object to the Company's Motion.

Accordingly, Adaman's Motion and Staff's Request for an Extension shall be granted.

1 IT IS THEREFORE ORDERED that Adaman's **Motion to Amend Application is granted.**

2 IT IS FURTHER ORDERED that Staff should file a **Reply to Adaman's Comments to Staff**
3 **Report or, alternatively, a Supplemental Staff Report, no later than April 14, 2010.**

4 IT IS FURTHER ORDERED that all parties must comply with Rules 31 and 38 of the Rules
5 of the Arizona Supreme Court and A.R.S. § 40-243 with respect to practice of law and admission *pro*
6 *hac vice*.


7 IT IS FURTHER ORDERED that withdrawal of representation must be made in compliance
8 with A.A.C. R14-3-104(E) and Rule 1.16 of the Rules of Professional Conduct (under Rule 42 of the
9 Rules of Arizona Supreme Court). Representation before the Commission includes appearances at all
10 hearings and procedural conferences, as well as all Open Meetings for which the matter is scheduled
11 for discussion, unless counsel has previously been granted permission to withdraw by the
12 Administrative Law Judge or the Commission.

13 IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113 - Unauthorized
14 Communications) applies to this proceeding and shall remain in effect until the Commission's
15 Decision in this matter is final and non-appealable.


