RE: **REQUEST FOR ADMINISTRATIVE CLOSURE  
PINE WATER COMPANY (DOCKET NO. W-03512A-07-0019, W-03512A-07-0100, W-03512A-06-0407, W-03512A-06-0613)**

On October 9, 2009, Pine Water Company ("Pine" or "Company") filed a Notice of Condemnation application (W-03512A-09-0486) with the Arizona Corporation Commission ("ACC"). The Company indicated that all of the assets of Pine, including its Certificate of Convenience and Necessity ("CC&N") had been condemned and acquired by the Pine Strawberry Water Improvement District ("District"). On March 26, 2010, Staff filed a recommendation in the condemnation application docket (W-03512A-09-0486) that the CC&N be cancelled.

Staff, therefore, recommends that all of the outstanding dockets associated with Pine Water Company with a status of open and/or compliance due be closed which includes consolidated Docket Nos. W-3512A-07-0019, W-03512A-07-0100, W-0512A-06-0407, W-03512A-06-0613.
