11 **BY THE COMMISSION:**

12 On August 10, 2004, the Arizona Corporation Commission ("Commission") issued Decision
13 No. 67166 which approved a rate increase and authority to incur long-term debt for Pine Water
14 Company ("Pine Water" or "Company"), and imposed certain other conditions on the Company.

15 On October 9, 2009, Pine Water filed a Notice of Condemnation application (W-03512A-09-
16 0486) with the Commission in which the Company indicated that all of the assets of Pine, including
17 its Certificate of Convenience and Necessity ("CC&N"), had been condemned and acquired by the
18 Pine-Strawberry Water Improvement District ("District").

19 On March 31, 2010, the Commission's Utilities Division ("Staff") filed Request for
20 Administrative Closure in this matter. Staff recommended that all of the outstanding dockets
21 associated with Pine Water with a status of open and/or compliance due be closed, including Docket
22 No. W-3512A-03-0279.
