**PROCEDURAL ORDER**  
**(Administratively Closes Docket)**

11 **BY THE COMMISSION:**

12 On February 12, 1998, E&R Water Company, Inc. filed an application with the Arizona  
13 Corporation Commission ("Commission") for approval of the transfer of certain portions of assets  
14 and corresponding Certificates of Convenience and Necessity ("CC&N") to Pine Water Company,  
15 Inc. ("Pine Water" or "Company"). On June 19, 1998, in Decision No. 60972, the Commission  
16 approved the sale of assets and transfer of CC&N to Pine Water.

17 On October 9, 2009, Pine Water filed a Notice of Condemnation application (W-03512A-09-  
18 0486) with the Commission in which the Company indicated that all of the assets of Pine, including  
19 its Certificate of Convenience and Necessity ("CC&N"), had been condemned and acquired by the  
20 Pine-Strawberry Water Improvement District ("District").

21 On March 31, 2010, the Commission's Utilities Division ("Staff") filed Request for  
22 Administrative Closure in this matter. Staff recommended that all of the outstanding dockets  
23 associated with Pine Water with a status of open and/or compliance due be closed, including Docket  
24 Nos. W-3512A-98-0078 and W-01576A-98-0078.
