PROCEDURAL ORDER
(Administratively Closes Docket)

19 **BY THE COMMISSION:**

20 On June 21, 2006, Raymond R. Pugel and Julie B. Pugel, as trustees of the Raymond R. Pugel
21 and Julie B. Pugel Family Trust, and Robert Randall and Sally Randall (collectively "Pugel
22 Complainants"), filed with the Arizona Corporation Commission ("Commission") in Docket No. W-
23 03512A-06-0407 a Complaint against Pine Water Company ("Pine Water" or "Company"). The
24 Complaint sought to delete property owned by the Complainants from Pine Water's certificated
25 service area based on the allegation that Pine Water was not able to provide satisfactory and adequate
26 water service in a reasonable time and at a reasonable rate.

27 On February 23, 2007, James Hill and Sioux Hill, as trustees of The Hill Family Trust, filed a
28 similar complaint ("Hill Complaint") against Pine Water in Docket No. W-03512A-07-0100.

On May 16, 2007, a Procedural Order was issued consolidating the dockets.

1 On October 9, 2009, Pine Water filed a Notice of Condemnation application (W-03512A-09-
2 0486) with the Commission in which the Company indicated that all of the assets of Pine, including
3 its Certificate of Convenience and Necessity ("CC&N"), had been condemned and acquired by the
4 Pine-Strawberry Water Improvement District ("District").

5 On March 31, 2010, the Commission's Utilities Division ("Staff") filed Request for
6 Administrative Closure in this matter. Staff recommended that all of the outstanding dockets
7 associated with Pine Water with a status of open and/or compliance due be closed, including Docket
8 Nos. W-3512A-06-0407 and W-3512A-07-0100.

9 IT IS THEREFORE ORDERED that **Docket Nos. W-03512A-06-0407 and W-03512A-07-
10 0100 are hereby administratively closed.**
