PROCEDURAL ORDER
(Administratively Closes Docket)

BY THE COMMISSION:

On January 12, 2007, Brent Weekes ("Complainant") filed with the Arizona Corporation Commission ("Commission") a Complaint against Pine Water Company ("Pine Water" or "Company"). The Complaint sought to delete property owned by the Complainant from Pine Water's certificated service area based on the allegation that Pine Water was not able to provide satisfactory and adequate water service in a reasonable time and at a reasonable rate.

On October 9, 2009, Pine Water filed a Notice of Condemnation application (W-03512A-09-0486) with the Commission in which the Company indicated that all of the assets of Pine, including its Certificate of Convenience and Necessity ("CC&N"), had been condemned and acquired by the Pine-Strawberry Water Improvement District ("District").

On March 31, 2010, the Commission's Utilities Division ("Staff") filed Request for Administrative Closure in this matter. Staff recommended that all of the outstanding dockets associated with Pine Water with a status of open and/or compliance due be closed, including Docket No. W-3512A-07-0019.


