13 **BY THE COMMISSION:**

14 On February 12, 1998, Williamson Waterworks, Inc. ("Williamson Waterworks") filed an
15 application with the Arizona Corporation Commission ("Commission") for approval of the transfer of
16 certain portions of assets and corresponding Certificates of Convenience and Necessity ("CC&N") to
17 Pine Water Company, Inc. ("Pine Water" or "Company"). On June 19, 1998, in Decision No. 60972,
18 the Commission approved the sale of assets and transfer of CC&N to Pine Water.

19 On October 9, 2009, Pine Water filed a Notice of Condemnation application (W-03512A-09-
20 0486) with the Commission in which the Company indicated that all of the assets of Pine, including
21 its Certificate of Convenience and Necessity ("CC&N"), had been condemned and acquired by the
22 Pine-Strawberry Water Improvement District ("District").

23 On March 31, 2010, the Commission's Utilities Division ("Staff") filed Request for
24 Administrative Closure in this matter. Staff recommended that all of the outstanding dockets
25 associated with Pine Water with a status of open and/or compliance due be closed, including Docket
26 Nos. W-03512A-98-0079 and W-02137A-98-0079.


