**DISPUTED ISSUE NO. 2: CONCERNS REGARDING PROVISIONING LOOPS  
WHERE QWEST USES INTEGRATED DIGITAL LOOP CARRIER**

AT&T believes Staff's legal analysis regarding competitive local exchange carrier  
("CLEC") access to loop qualification information is correct. AT&T agrees with Staff's  
analysis and conclusions at pages 7-8. AT&T must point out that Qwest's proposed  
SGAT language in the past has been too narrow. Therefore, any language proposed by  
Qwest in response to Staff's recommendation should be subject to the review of the  
CLECs and Staff to determine whether the language proposed by Qwest for inclusion in  
the Statement of Generally Available Terms and Conditions ("SGAT") meets the  
requirements of the Federal Communications Commission's orders.




