**MOTION FOR EXTENSION OF TIME TO
FILE RESPONSE TO REQUEST FOR
SUMMARY ADJUDICATION**

The Arizona Corporation Commission Staff ("Staff") herein requests an additional extension of time, until Friday April 16, 2010, to file a Response to the Request for Summary Adjudication filed by Coronado Utilities, Inc. ("Coronado" or "Company") on March 22, 2010.

Pursuant to the procedural order issued in this matter on July 24, 2010, responses to motions are due within five calendar days of the filing date of the motion. On March 24, 2010, Staff filed a request for an extension of time until April 9, 2010 to file a Response to the Request for Summary Adjudication because the Company's request involved substantive non-procedural legal issues. On March 24, 2010 the Company indicated that it did not oppose Staff's request and suggested that it would also be acceptable to the Company if Staff filed it's response on April 16, 2010, the due date of Staff's surrebuttal testimony. Staff respectfully requests additional time, until April 16, 2010, to allow an opportunity to respond to the Company's legal arguments regarding Staff's recommendation.
