12 **BY THE COMMISSION:**

13 On June 19, 1998, in Decision No. 60972, the Arizona Corporation Commission
14 (“Commission”) approved the application of Williamson Waterworks, Inc. (“Williamson” or
15 “Company”) to transfer its assets and Certificate of Convenience and Necessity (“CC&N”) to
16 Strawberry Water Company, Inc. (“Strawberry Water”).

17 On October 9, 2009, Strawberry Water filed a Notice of Condemnation application (W-
18 03513A-09-0485) with the Commission in which the Company indicated that all of the assets of
19 Strawberry Water, including its CC&N, had been condemned and acquired by the Pine-Strawberry
20 Water Improvement District (“District”).

21 On April 8, 2010, the Commission’s Utilities Division (“Staff”) filed Request for
22 Administrative Closure in this matter. Staff recommended that all of the outstanding dockets
23 associated with Strawberry Water Company with a status of open and/or compliance due be closed,
24 including Docket Nos. W-03513A-98-0081 and W-02137A-98-0081.
