**MOTION FOR EXTENSION OF
TIME TO FILE RATE CASE**

19 The Cerbat Water Company, Inc. ("Company") hereby moves for an extension of
20 time to file a permanent rate application. Currently, the Company is scheduled to file its
21 application by no later than April 30, 2010. The Company is seeking additional time to
22 file the application and give the Company until June 1, 2010 to file the permanent rate
23 application.

25 This extension of time is necessary due to workload and time constraints of the
26 accountant analyzing the revenue requirements and designing the proposed rates in the
27 application. Further, the Company and Arizona Corporation Commission
28

1 (“Commission”) Staff are meeting in May to discuss issues concerning the permanent
2 rate application, which may enable the Company to address problems in the initial
3 application and thereby make the case more efficient from the outset.

5 Company representatives have spoken with Commission Staff regarding this
6 motion and Commission Staff had no objection to extending the deadline for 30 days.
7 The Company is requesting June 1, 2010 rather than May 31, 2010 as the filing deadline
8 due to previously scheduled timing conflicts arising on that day.
