PROCEDURAL ORDER

BY THE COMMISSION:

On April 23, 2010, Coronado Utilities, Inc. ("Coronado") and the Arizona Corporation Commission ("Commission") Utilities Division ("Staff") participated in a telephonic procedural conference with the presiding Administrative Law Judge to clarify the public comment and hearing schedule for this matter. The hearing in this matter is set to commence on May 5, 2010, at 10:00 a.m. at the Commission's Tucson offices. Public Comment will be taken at the beginning of the hearing, to be followed by the evidentiary portion of the proceeding. This is not a change to the schedule. Following the discussion, the parties agreed that the scheduled pre-hearing conference on May 3, 2010, would not be needed.

IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend, or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.


