**REQUEST FOR  
MODIFICATION TO PROCEDURAL  
SCHEDULE**

The Arizona Corporation Commission Staff ("Staff") herein requests minor modifications to the procedural schedule contained in the Commissions May 3, 2010 procedural order. On March 29, 2010 Arizona Electric Power Cooperative, Inc. ("AEP") filed a Request for Procedural Conference with a proposed revised procedural schedule. On April 14, 2010 a procedural conference was held to discuss, among other matters, the proposed schedule. At the procedural conference Staff requested the addition of a July 30, 2010 due date for Staff direct testimony regarding prudence review. No party opposed Staff's request.

Under the procedural order issued on May 3, 2010, however, the new date for Staff testimony on its prudence review was not included. Staff believes that this was probably just an oversight, and respectfully requests a modification of the new schedule to include the July 30, 2010 due date for Staff direct testimony regarding prudence review. Staff also notes that the August 29, 2010 due date for AEP/Members rebuttal testimony falls on a Sunday. Staff suggests that this date be changed to fall on Monday August 30, 2010.
