PROCEDURAL ORDER

On March 1, 2010, Gary R. Bahr and Larry C. Rowley ("Complainants") filed with the Arizona Corporation Commission ("Commission") a Complaint ("Complaint") against Qwest Corporation ("Respondent").

2 of the Arizona Supreme Court and A.R.S. §40-243 with respect to practice of law and admission *pro*  
3 *hac vice*.

4 IT IS FURTHER ORDERED that that the Presiding Administrative Law Judge may rescind,  
5 alter, amend, or waive any portion of this Procedural Order either by subsequent Procedural Order or  
6 by ruling at hearing.


