On June 21, 2006, Raymond R. Pugel and Julie B. Pugel, filed a Complaint against Pine Water Company. On February 23, 2007, James Hill and Sioux Hill filed a similar complaint against the Company. On May 16, 2007, a Procedural Order was issued consolidating the dockets. On October 9, 2009, Pine Water filed a Notice of Condemnation on assets associated with their CC&N. On March 31, 2010, Staff filed a motion requesting all outstanding dockets associated with Pine Water be closed, including Docket Nos. W-03512A-06-0407 and W-03512A-07-0100.
