2 On September 5, 2002, the Securities Division filed a Temporary Cease and Desist Order
3 against Respondents. The Respondents requested a hearing and filed Answers. On March 11,
4 2003, the Commission issued a stay in the administrative proceedings and granted leave to file this
5 matter in Superior Court.

6 On March 25, 2003, the Commission filed a Verified Complaint and requested the
7 appointment of a receiver in Maricopa County Superior Court, CV2003-005724, which was
8 granted.

9 As of March 19, 2010, the civil matter has been resolved as to all individual defendants.
10 The court appointed receivership continues over the entities under the supervision of the Superior
11 Court. The Commission approved settlements with five defendants. The Superior Court granted
12 the Commission's Partial Motion for Summary Judgment and issued a Final Judgment against one
13 defendant. All individual defendants are under a permanent injunction from violating the
14 Securities Act and ordered to pay restitution and civil penalties.

By resolving the civil case, the administrative case has been resolved.


IT IS ORDERED that the administrative case, Docket No. S-03491A-02-0000, be dismissed.
