**TESTIMONY OF RODNEY L. MOORE**

Through this filing, Arizona-American Water Company ("Arizona-American") objects to the revenue requirement testimony of RUCO's witness Rodney L. Moore set forth on page 5 of Mr. Moore's Rate Design Testimony. On page 5 of his Rate


1 Design Testimony, Mr. Moore recommends that the Commission consider a phase-in of  
2 rates over a three-year period and that the Company consider foregoing “significant  
3 returns” during that phase-in period.

4 Arizona-American objects to this revenue requirement testimony submitted  
5 by Mr. Moore, who is RUCO’s rate design witness. RUCO has had ample opportunity to  
6 provide a recommendation on revenue requirement issues such as this in either the Direct  
7 Testimony and/or Surrebuttal Testimony of Mr. Smith or Mr. Rigsby. Indeed, when asked  
8 about whether RUCO had considered the phase-in recommended by Mr. Neidlinger, Mr.  
9 Smith testified that RUCO had not made that adjustment to its revenue requirement  
10 recommendation. *See* Transcript (4/29/10), at 942. If RUCO had such a recommendation,  
11 it should have provided it through one of its two revenue requirement witnesses.

12 For the reasons set forth above, Arizona-American objects to page 5 of Mr.  
13 Moore’s Rate Design Testimony and requests that it be stricken.
