On April 29, 2010, Arizona Public Services ("APS") filed its Application for Approval of its Schools and Government Renewable Energy Program (the "APS Application") in Docket No. E-01345A-10-0166 (the "Docket"). SolarCity Corporation ("SolarCity"), by and through its undersigned counsel and pursuant to R14-3-105 hereby respectfully moves for an Order granting it leave to intervene the Docket. In support of this Motion SolarCity states the following:

1) SolarCity is one of the largest installers of distributed solar systems in both Arizona and the nation.

2) SolarCity is one of the largest providers of solar design, installation, maintenance and financing services (collectively "Solar Services") to schools in the State of Arizona.

1 3) SolarCity and its school customers rely on the availability of APS' rebates to make
2 the provision of Solar Services financially feasible and advantageous.

4 4) The outcome of this Docket will directly and substantially affect the availability of
5 APS' rebates for solar projects involving schools and therefore, it will directly and substantially
6 affect SolarCity's ability to provide Solar Services to schools in APS' service territory.

8 5) Granting SolarCity intervener status will not or unduly broaden the issues or
9 prejudice APS and no other party can adequately represent SolarCity's interest in this matter.
