PRE-HEARING CONFERENCE)

BY THE COMMISSION:

On April 20, 2010, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Temporary Order to Cease and Desist ("T.O.") and Notice of Opportunity for Hearing ("Notice") against Global Trading Partners, LLC ("GTP"), Michael Eugene Gowens and Jane Doe Gowens, husband and wife (collectively "Respondents"), in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of stock or notes.

The Respondents were duly served with a copy of the Notice.

On May 10, 2010, a request for hearing was filed by Respondent Michael E. Gowens, individually and as "President" of GTP.


Accordingly, a pre-hearing conference should be scheduled. Respondent, may retain counsel or he may represent himself pursuant to the Commission's Rules of Practice and Procedure A.A.C. R14-3-101 *et seq.* and the Rules of the Arizona Supreme Court.

IT IS THEREFORE ORDERED that a **pre-hearing conference** shall be held on **June 2, 2010, at 11:00 a.m.**, at the Commission's offices, 1200 West Washington Street, Room 100, Phoenix, Arizona.

4 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.
