AND WIFE**


The Securities Division of the Arizona Corporation Commission ("Division") requests that the final contested hearing scheduled for May 19 and 20, 2010 be vacated. On May 13, 2010, a Securities Open Meeting was held and the Commission approved an Order to Cease and Desist, Order for Restitution, Order for Administrative Penalties and Consent to Same regarding Troy Dee Truvillion and Jenia Demitrova, husband and wife ("Consent Order"). A final decision number regarding the Consent Order is pending. The Consent Order absolves the need for the final contested hearing requested by Troy Dee Truvillion and therefore the May 19 and 20, 2010 hearing dates may be vacated<sup>1</sup>.
