Pursuant to Staff's April 30, 2010 electronic mail message in the above-referenced matter, United Telecom, Inc. dba Rodeo Telecom, Inc. ("Rodeo Telecom" or the "Company"), by its regulatory consultants, hereby provides the following information.

Enclosed is a copy of Rodeo Telecom's Arizona Corporation Commission corporate Certificate of Good Standing ("CoGS"). At the time of the Company's application for Certificate of Convenience and Necessity submission, the Company had been newly granted corporate authority to transact business. Although the Company has not transacted business in Arizona pending the grant of its application, the attached CoGS demonstrates that the Company remains in Good Standing. Please note, that the CoGS makes reference exclusively to the Company's forced fictitious name in Arizona, "Rodeo Telecom, Inc." This is the only name in which the CoGS will be issued.

Also enclosed is a clarified response to Staff's First Set of Data Requests to Rodeo Telecom data request 1.2(b), confirming that the Company has at no time had an application to provide intrastate telecommunications services been denied. The amendment is incorporated into a replacement page to the original response.


