
As per your directive, we corresponded with APS by the enclosed correspondence from this firm dated April 6, 2010 requesting a meeting to discuss and attempt to resolve all pending issues. In response to your directive that we provide you with APS's response, enclosed please find correspondence dated April 20, 2010 from Thomas L. Mumaw, Senior Attorney of the Law Department of Pinnacle West Corporation, declining any further meeting at this time "to go over old territory." Accompanying Mr. Mumaw's correspondence, we are also providing you with his attachment thereto.

As you can see, APS has unilaterally defined our ongoing multiple dispute as "old territory" and has once again closed the door in our face. Furthermore, APS's position is steadfastly based upon only selective data and certainly does not consider all of the data which has been presented to date.

In addition to following up with you as directed so that you can give this matter further consideration as previously promised, please be advised that our clients have been left with no choice but to file a formal complaint consistent with your previous suggestion.

History will substantiate that our clients are long standing customers of APS for many decades and have no choice but to fulfill their requirements for electricity from APS as their sole provider. APS's refusal to give any further consideration to that which has already been presented is indicative of its dogmatic approach to customers who would question the fairness and integrity of its operation. By filing the instant complaint, our clients are hopeful that the Arizona Corporation Commission will take a stance which not only protects the rights of our clients, but the multitudes that may find themselves in the same position as our clients.

Dear. Mr. Rubin:

In reference to your letter dated April 6, 2010, I have been asked to respond on behalf of Mr. Froetscher. Mr. Froetscher has met with your client on at least two prior occasions. The result of the most recent of these meetings was a letter to Mr. Bien-Willner dated March 18, 2010. A copy of that letter is attached for your convenience. APS has also provided to Mr. Bien-Willner a letter detailing the results of the Company's investigation of his complaint dated April 8, 2010. A copy of that letter is also attached for your convenience. Finally, the matter of the estimated bill at Mr. Bien-Willner's Bridgewater property, left open at the time of Mr. Froetscher's March 18th letter, has now been concluded to the Company's satisfaction and in accordance with Service Schedule 8 (Bill Estimation) as approved by the Arizona Corporation Commission ("ACC"). A copy of the letter dated April 15, 2010 to Mr. Bien-Willner relating to that account is again attached for your convenience.


Simply stated, APS believes all the matters referenced in your April 6th letter have been addressed by the Company and, in most instances, by either the ACC or the Superior Court. Absent any new information of a tangible nature, the Company sees no value to a meeting at this time to go over old territory. If Mr. Bien-Willner has new information concerning any of these past issues, APS
