Effective July 1, 2010, subject to regulatory approval of an Application filed on April 30, 2010 with the Arizona Corporation Commission, Verizon Long Distance LLC ("VLD") will no longer offer in Arizona its: Business Travel Card Service, Consumer Travel Card Services (Travel Card, Joint Offer Card, Away from Home Services), Personal Toll Free Service, and its Plan "E Smart Touch" Service. 
