PROCEDURAL ORDER

BY THE COMMISSION:

On July 2, 2007, Diablo Village Water Company ("DVWC" or "Company") filed an application with the Arizona Corporation Commission ("Commission") for approval of a rate increase.

On March 2, 2009, DVWC filed an application for the sale of assets and cancelation of its Certificate of Convenience and Necessity ("CC&N"). DVWC sought authority to sell its assets to the Metropolitan Domestic Water Improvement District.

By Procedural Order dated March 3, 2009, the rate application was held in abeyance pending the approval of the sale of assets.

On October 6, 2009, the Commission issued Decision No. 71290 which granted the application of DVWC to sell its assets and cancel its CC&N.

On January 29, 2010, DVWC filed the closing documents for the sale with the Commission pursuant to the directive of Decision No. 71290.




