**ORDER AMENDING DECISION NO.
71316 PURSUANT TO A.R.S § 40-252**

Having considered the entire record herein and being fully advised in the premises, the Commission finds, concludes, and orders that:

FINDINGS OF FACT

1. On October 30, 2009, the Arizona Corporation Commission ("Commission") issued Decision No. 71316, approving a surcredit of \$0.08 per-therm for UNS Gas, Inc. ("UNS Gas" or "Company"). The surcredit became effective on November 1, 2009, and was scheduled to continue for twelve months, or until UNS Gas' purchased gas adjustor ("PGA") bank balance reaches zero, whichever occurs first.

2. On May 10, 2010, UNS Gas filed a Motion for Extension of Time or, in the Alternative, Motion to Amend Decision No. 71316 ("Motion"). The Company's Motion states that its PGA bank balance was zero as of April 30, 2010 and, in accordance with Decision No. 71316, the surcredit was scheduled to expire and customers would begin paying a higher per therm rate for gas. Rather than eliminating the surcredit immediately, UNS Gas proposes to extend the credit until July 1, 2010 to avoid the possibility of customers' confusion related to the base rate increase that became

2 **ORDER**

3 IT IS THEREFORE ORDERED that Decision No. 71316 is hereby amended, pursuant to
4 A.R.S. § 40-252, and UNS Gas, Inc. is authorized to continue its \$0.08 PGA surcredit, until July 1,
5 2010.

6 IT IS FURTHER ORDERED that in all other respects, Decision No. 71316 shall remain in
7 full force and effect.

8 IT IS FURTHER ORDERED that this Decision shall become effective immediately.
