TELEPHONICALLY**


By procedural order dated May 11, 2010, an evidentiary hearing in this matter was scheduled to commence June 15, 2010 at the Kingman Powerhouse in Kingman, Arizona. Commission Staff voiced no opposition to holding the hearing in Kingman at the May 6, 2010 procedural conference where the issue of location was raised. However, due to resource considerations, Staff requests that its sole witness, Ms. Laura Furrey, be able to provide her oral testimony telephonically.

Staff has made inquires to the Applicant, Hualapai Valley Solar, LLC, and is informed that the facilities at the Kingman Powerhouse would support a witness providing testimony telephonically. Further, Staff has discussed the request with each party and none has indicated any objection to accommodating Staff's request.
