**REQUEST FOR RECONSIDERATION AND  
MODIFICATION OF PROCEDURAL ORDER**

Staff of the Arizona Corporation Commission ("Staff") hereby respectfully submits this request for reconsideration and modification of the November 13, 1998, Procedural Order issued in this matter.

Staff believes that this matter should proceed expeditiously, and further believes that there is an opportunity to compress the procedural schedule somewhat without prejudicing the

1 intervenors. Consequently, Staff requests that the date for filing responsive testimony by Staff,  
2 Arizona Public Service Company and Tucson Electric Power Company be moved from December  
3 4 to December 2, 1998, with the hearing to begin on December 3, 1998.

4 To accommodate these proposed dates, Staff would request only that the filing time  
5 for intervenors be moved from 4:00 p.m. to noon on November 30, 1998, and that the formalities  
6 of a question and answer format not be required of the testimony to be filed on December 2, 1998.

7 In addition, Staff requests that an opportunity be provided, if necessary, to clarify or expand on this  
8 pre-filed responsive testimony during direct examination.

9 The testimony and hearing dates requested herein will ensure that this matter proceeds  
10 expeditiously to hearing without prejudicing the interests of intervenors. Staff, therefore, requests  
11 that this motion be granted.
