**POST HEARING MEMORANDUM OF  
NEW WEST ENERGY**

23 Early in this proceeding New West Energy offered several suggested changes to the  
24 settlement agreement. However, during the hearings the parties to the settlement agreement,  
25 partially at the urging of New West Energy, renegotiated the terms of the settlement to increase

1 the "adder" available to customers choosing an alternate electricity supplier. Because of this  
2 change in the settlement agreement:

- 3 1. New West Energy withdraws all of its suggested changes to the settlement  
4 agreement;
- 5 2. New West Energy withdraws any opposition to the settlement agreement; and
- 6 3. New West Energy supports the settlement agreement, as amended, and urges that  
7 the Commission accept the amended settlement agreement.
