Tucson Electric Power Company ("TEP"), through undersigned counsel, hereby requests that the Commission issue a procedural order extending certain dates for filing its Code of Conduct, as follows:

Pursuant to Section 7.1 of the Settlement Agreement dated June 9, 1999 ("Agreement") filed in this docket, TEP filed its Interim Code of Conduct ("Interim Code") on July 21, 1999. TEP received no comments on the Interim Code.


Pursuant to Decision No. 62103 dated November 30, 1999, TEP was to file its Proposed Final Code of Conduct ("Final Code") on or about February 27, 2000. However, Staff has recommended that the APS Code of Conduct ("APS Code") be used as a model for TEP's Final Code. TEP has been informed that a proposed agreement has been reached between Staff and APS

1 regarding the APS Code that will be considered by the Commission at its March 28 and March 29,
2 2000 Open Meetings. TEP requests that the Commission extend the filing date for the Final Code so
3 that TEP may review the final APS Code and thereby have an opportunity to incorporate any
4 changes therein to TEP's Final Code.

6 TEP will continue to operate under the Interim Code until the Commission rules on its Final
7 Code. In making this motion, TEP reserves its right to request modifications with respect to any
8 final Code of Conduct that the Commission may require under the Rules.
