**PROCEDURAL ORDER**


**BY THE COMMISSION:**

On March 6, 2000, Tucson Electric Power Company ("TEP") filed a Motion for Extension of time to file its Proposed Code of Conduct to permit TEP the opportunity to review the Code of Conduct the Arizona Corporation Commission ("Commission") approved for Arizona Public Service Company ("APS"). On March 9, 2000, the Commission Utilities Division Staff ("Staff") filed a Response to TEP's Motion in which Staff did not oppose delaying TEP's filing of a Proposed Code of Conduct until the APS Code of Conduct is finalized. A short delay will not prejudice any party and will facilitate the efficient approval of a Code of Conduct for TEP. TEP is currently operating under an interim Code of Conduct. The Commission approved APS' Code of Conduct at its March 29,2000 Open Meeting.

IT IS THEREFORE ORDERED that TEP shall file a final proposed Code of Conduct on or before April 24, 2000.

1 IT IS FURTHER ORDERED that Staff and other interested parties shall file  
2 comments/recommendations (including recommendations for a hearing) to the final proposed Code  
3 of Conduct on or before May 8, 2000.
